How to Add NO HOME MEDS Entry to Drug File

Occasionally, a patient will come into a facility with no home medications or an unknown medication. An entry can be added to the Drug file for documentation of this scenario.

You would first be creating the Dispense Drug, then later asked to create the Pharmacy Orderable Item. You can edit any field as you see fit for your needs.
